RULES & REGULATIONS

Members and Fees

1. (a) The Membership shall consist of **Honorary, Patron, Life and Institutional Members**.
(b) Application for membership shall be made on the prescribed form to the Managing Committee of the Association Admission will be subject to the approval of this committee.
2. All those desirous of become Life members or Patron members will be required to be introduced by two existing members.
3. (a) **Honorary Members** : The Managing Committee may recommend to the General Meeting of the members, the name of one person for consideration as an Honorary Member in recognition of outstanding services rendered by him for the advancement of the Chemical Industries or Chemical Technology. Such person when approved, shall be deemed to be an Honorary Member.
(b) **Patron Members** : An individual who is interested in the objectives of the association is eligible to become a patron member on Payment of a sum of **Rs.5000/-** plus entrance fee Rs.50/- w.e.f. dt.1/11/2019.
(c) **Life Members** : A person eligible to become Life Member of the Association can do so by paying a sum of **Rs.2000/-** plus entrance fee Rs.50/- w.e.f. dt.1/11/2019.
(d) **Institutional Members** : Any institution/corporate body interested in the objectives of the association can apply to the managing committee, along with membership fees of **Rs.10,000/-** plus entrance fee Rs.50/- for approval/admission. Such institutional members will have a right to depute **two persons** for participating in the activities organized by the association. Only one member will be given a **voting right**. Such nominees will enjoy all the facilities of life member.
(e) **Entrance Fees** : All persons becoming members of the association (including institutional members) will pay an **entrance fee of Rs.50/-** only which will be credited to the central reserve fund.
(f) **Eligibility of the member** : A member shall be with at least **five year experience** in a responsible position in **manufacturing, production, Research, teaching or product testing Sales/Marketing, Govt. Organisation etc. or related in any field of chemical technology**. Except that the managing committee may at its discretion elect as a member a person possessing exceptional training and experience which be of value to the association. An Application for the Membership should have 2 Photographs and A photo copy of the last Qualification.

In determining **fulfilment of experience** requirement a Bachelor's degree in natural sciences or a diploma or a degree in any branch of chemical technology will be counted as equivalent of two years practical experience. A bachelor's degree in technology in addition to a bachelor's degree in natural sciences shall be counted the equivalent of four years of practical experience. Each more advanced degree in natural sciences or technology shall be counted as the equivalent of one year's practical experience.
4. **Students**, who are willing to attend/participate in the programmes of the association, can do so by paying a nominal fees, as decided by the Managing Committee.
5. **Fields of Chemical Technologies and abbreviations** : Gen. Chemistry (**CH**)/ Textile Technology (**T.T.**) Chemical Engg. (**CHE**) Bio-technology (**BIO**)/ Pharmaceuticals (**PHA**)/ Plastic Engg. & Tech. (**PLA**)/ Membrane (**MEM**)/ Petro Chemicals (**PET**)/ Oils & Fats Technology (**OFT**)/ Environment Engg.
