Guidelines for Student Membership

- 1. Application Form duly filled in introduces and signed by 2 Faculty Members (preferably ACTI Members) alongwith bonafide certificate from College, last year marksheet (self attested), be submitted to ACTI.
- 2. Fees: Rs. 200/- (Rs. Two Hundred only) + Rs.50/- (Rs. Fifty only) Entry Fee, to be paid at time of Application.
- 3. The Membership is only for 1 (One) year & to be renewed every year by paying Membership Fee only which is Rs.200/- till the Study Course is completed.
- 4. A Student Member shall not have a Voting right.
- 5. He/She shall enjoy all other rights like other members of ACTI.
- 6. The student membership ceases on completion of the study course and thereafter he/she shall have to opt for Life Membership or Patron Membership by paying the difference between the amount of Life Member/Patron Member and the amount paid during student membership. Minimum years of student membership should be 3 years.
- 7. Any recognized Institute/College/University where Textile Chemistry/Chemical Techno./Science is taught and he/she is student may apply for Student Membership.
- 8. The following documents to be submitted alongwith Application Form.
 - 1) Two Passport size Photographs.
 - 2) Bonafide Certificate of Institution/College/University of present study.
 - 3) ID Card of Institute/College/University. (Any one)
 - 4) ACTI ID Card will be supplied after completion of Application form and approval of ACTI Committee. Each year ID Card of ACTI to be registered till Student Membership is continued. ID Card of ACTI to be carried with whenever ACTI Office is attended for any purpose.

Subsequent to the talk the undersigned had with your Mr. Pavan Panwala for the ACTI Membership Application Forms (Normal & Student). We had already sent to him. This is an Introductory letter regarding Student Membership being introduced W.E.F. 1st April, 2022 for the first time in our Association, which reads as under:

Effective from 1st April, 2022, ACTI, Association of Chemical Technologists (India), Ahmedabad has decided to register the students of Chemistry & Chemistry Technology stream of students who will be completing the Degree course or Diploma course after three years, means those who have completed first year and they are bonafide student of that respective college with the nominal fee of **Rs.200/**- every year to be paid to ACTI and after completion their course they will be registered with ACTI record either Life Members or Patron Member by paying the difference amount of that respective membership and what they have paid of completion of course.

Students Member will be given "ID Card of Student Membership with registered No. to each." Student Member will have to fill up the Student Membership form with endorsement of the college authority. After completion of their course they will be given Permanent ID Card of ACTI.

ACTI will organize various promotional activities to upgrade their soft skills which will cover up their respective field Programmes, Seminars, Competition, Visits attend conference or Exhibitions to improve their knowledge, Skills and Expose them to various promotional opportunities for batter prospects in their expected fields. During this period their performance and level of skill acquired will be awarded as "STAR STUDENT – ACTI...... (Name of College) and they would be awarded, certificate, incentives or any other prospective opportunities based on their talent of creativity.

This is a very new initiative taken up by the members recently and will be administered by the Committee Members and respective college authorized staff or office. For this we expect to have MoU signed between ACTI and College/Institution.

It would be very easy to function in that set up. Kindly advise so as to have initial meeting to understand each other.
